**MINUTES**

- 1) **Call to Order at 4:12 PM.**
- 2) **Welcome & Introductions.** Commission introduced themselves as well as guests.
- 3) **Adoption of Agenda.** **Commissioner Pappas** moved to adopt: second **Commissioner Loucks. Passed unanimously.**
- 4) **Approval of Minutes: January 11, 2018 –** Discussion of procedures on the minutes and corrections will be made and will be brought back to May 17<sup>th</sup>, 2018 meeting for approval.
- 5) **Public Comment.** Commissioner Houlihan the newly appointed Commissioner gave a brief introduction of himself. He has served on the HLRC before and lived in Fresno since 1942. He enjoys working on preservation of history in Fresno County.
- 6) **Discussion of Officers –** Chairman Yovino visited Penny Raven, past Chairman to HLRC and let the Commission know that she is doing well she just had too much going on and had to cut back. There will be no Vice Chair at this point, we will check with County Counsel to see if we need to fill position. Chairman Yovino spoke on recognizing Penny Raven for her dedication and time on the Commission.

7) **Landmarks:**

A) **Inventory of Historic Sites in Fresno County.**

(1) Discussed the inventory list and how it is on the website but needs to be updated.

B) **Historic Places:**

i) **Discussion and Necessary Action**

(1) Sugar Pine Lumber Mill Water Tower – Commissioner Rodriguez passed out the application and went through it with Commission. The Sugar Pine Lumber Mill was established in 1921. It is located in Pinedale. The goal was to create jobs and industry in the Fresno Area. Commissioner Pappas requested a significant narrative be added to clarify the history of it and also the building of it. Commissioner Rodriguez has travelled as far as Eugene, Oregon to gather information on this. **ACTION** Commissioner Rodriguez will work on the requests of the Commission and bring it back for approval to submit application to Board of Supervisors at the May meeting.

(2) Tejpaal S. Bain introduced the application at 8605 Main St. in San Joaquin. This is the first Sikh Temple in Fresno County; the name of it is San Joaquin Gurdwara. It was started in Yuba City and moved to the Central Valley. Gurbinder S Dhaliwal spoke on the importance of the Gurdwara and how it has helped the Sikh Community come together in the farming communities in the area. Amarpreet S. Dhaliwal, San Joaquin Mayor Pro Tem spoke on how important this site is to the Community to become designated as it would be the first for San Joaquin. Naindeep Singh also spoke of the importance of the temple to Sikh Community and how growing up he travelled to attend service on Sundays. Commissioner Loucks inquired about newspaper articles on it and Commissioner Pappas offered to help them find information. They thought the Fresno Bee would have something. Commission would like to see some pictures as well. Commission would be happy to offer assistance to get application prepared and submit for approval by the Board of Supervisors. Karen will send Tejpaal a new application and will send Commissioner Pappas his information and the original application. **ACTION** This will be brought back for approval to submit application to Board of Supervisors at the May meeting.
